### Business Items:

1. Motion m/s/c (Carey-Mielke/Adamczyk) to approve the 07-22-20 minutes with the following amendment: business item #3 should remove the words "He will be hiring a detective to work three days a week for the Seven Towns." and replace them with "One of the county detectives will begin working at the Lakewood office three days a week."
2. Representatives from NWTC distributed hand-outs and discussed possible solutions for meeting the needs of the six towns for EMS continuing education (Brazeau is not included at this point, but Ryan Wendt, Town of Brazeau Chair, stated that he is 'on board' with conversation at this time). Questions were asked of Drs. Rafn and Rogalski, but the most important finding was that there are discrepancies in the information that we are receiving. For example, Drs. Rafn and Rogalski stated that EMS training could be done if the Seven Towns gathered a group of at least 5 or 6 people. Randall Smith, Dean of Public Safety at NWTC, attends the MAS meetings, and he insists that the minimum must be 10. Drs. Rafn and Rogalski will meet with Randall and a group of NWTC representatives will return to our next meeting for more discussion.
3. "Sheriff Skarban discussed his "Mission and Vision Values". The county will be bringing on a second person to assist Jim Plotkin so that Jim can concentrate more on recreational activities. This move adds no extra cost for the Seven Towns. A committee was formed to decide what the Seven Towns want from the NOCCO officer. Once these needs are known, the new position will be posted. Volunteer committee members are:

4. Jim Plotkin, Northern Oconto County Community Officer, gave his report and several questions were asked of him.
5. Ryan Giese, Animal Control Officer, stated that he needs to be familiar with the most current ordinances. He has purchased dog food, but otherwise has no needs at this time.
6. Andrew Stemp, Town of Doty Chair, distributed a hand-out comparing prices of waste disposal among the Seven Towns.
7. Adriane (Gigi) Bartels, Town of Riverview, has a contact from the Chequamegon National Forest office and will be meeting about Silent Sport Bike Trails.
8. Ann Hogan, Town of Riverview Chair, shared information about the chipping program this fall at the Riverview Brush Site. New equipment has been purchased and there will be a demonstration sometime in October. Details to follow.
9. Vision Statements were read by a representative from each town and then handed over to the secretary for publication at the next meeting (see attached page.)
