# TOWN OF MOUNTAIN BOARD MEETING FEBRUARY 09, 2021 MINUTES

The meeting was called to order by Chairman Maletzke at 7:00 p.m. at the Bill Lazansky Community Center. Roll call was taken with Sup.O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 2 in attendance. The agenda was posted on February 6, 2021. Motion to approve the agenda by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

**Treasurer's Report** was given by Clerk Kauzlaric with bank statements available for review. Motion to accept Treasurer's report by Maletzke. Seconded by Carey-Mielke. Motion carried.

Minutes of the Town Board meeting held January 12, 2021 were available for review. Motion to approve minutes as presented by Carey-Mielke. Seconded by O'Barski. Motion carried.

Budget Amendments – 2020 final budget amendments will be reviewed in March (some bills still outstanding).

Disbursements were available for all to review; checks #16284 to and including #16337 for disbursement of \$42,174.60, which includes auto withdrawal of payroll taxes; plus late checks #16338 to and including #16344 in the amount of \$838,164.19 for a total disbursement of \$880,338.79. Motion to approve disbursements by Carey-Mielke. Seconded by O'Barski. Motion carried.

Ambulance Report – Sup. Carey-Mielke presented overview of monthly calls; currently 3 calls above average for January with 23 calls; three (3) applications were received for PRN part-time positions. No motions are entertained.

Fire Department Report – Chief Harkema contacted Clerk Kauzlaric regarding report on engine repair out 2-3 weeks yet, as he was unable to attend meeting; Chair Maletzke mentioned there were no contacts from contractor for building repair; Fire Dept member Ryan G reported that there were a couple calls and they burnt one (1) brush pile at the quarry. No motions are entertained.

Animal Control Report – Ryan Giese mentioned call in Town of Breed that may need assistance of Oconto County Sheriff; 7 Towns board meeting discussed fee schedule could be set by Town of Mountain (as we employee Animal Control position); Ryan will work on information to present at March board meeting. No motions are entertained.

Cemetery Activity Update – Sup. @Barski stated there were a few calls on pending spring burials. No motions are entertained.

Application for Land Division – James/Hertzberg (Parcel #029-683111024) – application available for review;
 Chair Maletzke updated board members on plan commission discussions. Motion for approving CSM as presented and approving the Land Division by Carey-Mielke: Seconded by O'Barski. Motion carried.

7 Town Board/NOCCO Meetings Discussions – meeting on January 20th discussed Animal Control fee schedule could be set by Mountain; wild Ash Bore presentation and discussion on issues; Town of Townsend Chair to prepare rebuttal letter to NWTC; Committee to meeting to look at options and compose letter to Oconto County for possibility of splitting county with morthern half attached to Nicolet College in Rhinelander; discussion on Recycling / Solid Waste handling of electronics; defined vision statement for 7 Towns Board; working on Emergency Response Plan for northern towns for next meeting Town of Doty recently revamped and will share with other towns); Sup. Carey-Mielke sent communication to be read at meeting regarding Sheriff Skarban hiring of NOCCO Officer without Town representation during process. Next meeting April 21st at Town of Townsend. No motions are entertained.

**Town Office/Road Shop expansion project** – Chair Maletzke is working on drawings for shop expansion, which will look at including new larger space for Town records storage; old storage room could be turned into shared office space for board members. **Community Center exterior renovation project** – Sup. Carey-Mielke is working on the spec's and could have ready for a special town board meeting later this month. Tabled for future meeting.

**CWPP discussion** – Sup. O'Barski brought up issues discussed at last CWPP meeting, which included need for Fire Dept. member participation and attendance at meetings; need to look at other projects besides roadside clearing for after storm damage is cleaned up (example - educational materials at events, Smokey the Bear attendance at Memorial Day

parade, etc); looking at new burner system and possibilities of portable unit that 7 Towns could share; and looking at possibility of Lake Association member involvement. No motions are entertained.

USDA application review (fire department equipment) - board members discussed possible equipment needs besides SCBA's; generator would be an eligible equipment purchase; proposals received and application to be completed for review; looking for ideas of other items to add to application if funds would be available. Tabled for further information.
