The meeting was called to order by Chairman Maletzke at 7:01 a.m. at the Town Office. Roll call was taken with Sup. O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 0 in attendance. The agenda was posted on February 24, 2021. The meeting was called to order by Chair Maletzke at 7:00 p.m. at the Bill Lazansky Community Center. Roll call was taken with Sup.O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 4 in attendance. The agenda was posted on March 6, 2021. Motion to approve the agenda by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

Treasurer's Report was given by Clerk Kauzlaric with bank statements available for review. Motion to accept Treasurer's report by Maletzke. Seconded by Carey-Mielke. Motion carried.

Fire Department Report - Chief Harkema provided contact information for independent contractor for Fire Inspections; discussed unbiased inspections as a benefit to contract this service; gave board an update on the engine repair.

USDA application review – final equipment requests discussed by Fire Chief Harkema and Town board members for the grant application; Clerk Kauzlaric will complete final application and get to USDA representative; Chief Harkema will work on final specifications for bid process once approved. This application will be available for review and discussion at the Special Town Board meeting to be held on Saturday, March 27th.

Recycle Center/Solid Waste site updates / re-design – Sup. O'Barski inquired about previous plans for re-design of site; Chair Maletzke will find previous plans; board members discussed widening of driveway to brush site, which would allow for one way traffic into Recycle Center/Solid Waste site and out current brush site entrance, paving full site; moving oil collection tank/shed toward current employee building; create retaining wall to move scrap pile toward brush site and allow for additional collection bins on brush site side. The meeting was called to order by Chairman Maletzke at 7:00 a.m. at the Bill Lazansky Community Center. Roll call was taken with Sup. O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 4 in attendance. The agenda was posted on March 25, 2021. Motion to approve the agenda as posted on March 25, 2021 by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

Town Office/Road Shop Expansion sealed bids - no bids at this time; Chair Maletzke stated that Milbach Construction would have a bid for the meeting; attempted to contact representative; moved to next item.

Community Center exterior renovation sealed bids – one bid received marked "sealed bid"; another envelope from Oconto County unsure. Motion to accept bids received by Carey-Mielke. Seconded by Maletzke. Motion carried. Bid from Northeast Asphalt was opened, read and reviewed by board members. Envelope from Oconto County was opened and was not bid for asphalt project. Board members discussed holding approval of asphalt bid until the other project items bids are received and full project costs are known. Tabled to April town board meeting.

2021-2022 Road Salt Contract – WI DOT 2021-2022 contract inclusion request needs to be received by March 29th; reviewed current inventory and are required to order 80 ton from 2020-2021 season fill by April 15th; board members discussed possible needs and keep with the 80-ton regular season and 20-ton reserve. Motion to move as presented by Carey-Mielke. Seconded by O'Barski. Motion carried.

Town Office/Road Shop Expansion sealed bids – one (1) bid was received from Milbach Construction (rep was at town office instead of community center before 7:00 a.m.). Motion to accept the bid received by Carey-Mielke. Seconded by O'Barski. Motion carried. Bid is opened and read; board members reviewed bid received from Milbach Construction and options were discussed that could lower costs. Board members discussed the option to keep open to only vendors that had requested specifications; to allow for a comparison bid. Motion in light of not having enough information for a project with this kind of money; that we extend to only those who requested packet of information on this project that they have until our next board meeting to submit those bids with no further extensions to be provided by Carey-Mielke. Seconded by O'Barski. Motion carried.

USDA Grant Application review – Clerk Kauzlaric reviewed the equipment the Fire Department is requesting with the USDA grant funds; application will be submitted for approximately \$190,000 to take full advantage of 55% match with \$100,000 maximum funds match. Motion to move forward with the process of the USDA grant as outlined by Maletzke. Seconded by Carey-Mielke. Motion carried.

Fire Engine frame repair – Chair Maletzke informed the board members that Fire Chief Harkema discussed the frame issue with Terry's Manufacturing, who believes that the crack in the frame could be fixed with a multi-layered weld as it is not located at a load bearing position. Motion to have that repair done by O'Barski. Seconded by Carey-Mielke. Motion carried.

Delinquent Personal Property Taxes (write off old uncollectable) – during recent audit the auditor suggested the town board consider writing off some old personal property taxes sent to collections and still outstanding; unfortunately, report was not printed before the town laptop was taken for an update and they had issues and will not be returned until Monday. Tabled until the April town board meeting.
