TOWN OF MOUNTAIN BOARD MEETING MAY 11, 2021 MINUTES

The meeting was called to order by Chair Maletzke at 7:00 p.m. at the Bill Lazansky Community Center. Roll call was taken with Sup.O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 13 in attendance. The agenda was posted on May 8, 2021. Motion to approve the agenda posted on May 8, 2021, by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

Treasurer's Report was given by Clerk Kauzlaric with bank statements available for review. Motion to accept Treasurer's report by Carey-Mielke. Seconded by O'Barski. Motion carried.

Minutes of the Town Board meeting held April 13, 2021, were available for review. Sup. Carey-Mielke suggested correction to minutes under Ambulance Report – "Sup, Carey-Mielke stated that he had met his term limit and a new member should be appointed" be restated/corrected to: "Sup. Carey-Mielke stated that there are term limits when asked by Chairman Maletzke if there was a term limit to this position. For clarification, as it was an agenda item, I believe it was assumed that his had expired and as indicated that was the impression that we had in the communication received by MAS." Motion to approve minutes as amended by Maletzke. Seconded by O'Barski. Motion carried.

Budget Amendments – no amendments at this time.

Disbursements were available for all to review; checks #16474 to and including #16520 for disbursement of \$92,589.89, which includes auto withdrawal of payroll taxes; plus check #16502 in the amount of \$275.00 was VOIDED due to return of blades for cemetery tractor and check #16521 issued in the amount of \$239.00 for the corrected invoice for a total disbursement of \$92,553.89. Motion to approve disbursements by Carey-Mielke. Seconded by O'Barski. Motion carried.

Ambulance Report - Sup. Carey-Mielke presented overview of monthly calls, which are still above average; minor roof damage will be repaired.

 Citizen Member appointment – No motions are entertained as it was confirmed that Jerrold Herman's appointment does not end until April 2022.

Fire Department Report – Chief Harkema reported that there were three (3) fires recently with wildland and structure damage; Command vehicle received 2021 annual service; part for Tender is \$800 - \$1,600 to repair (which can be completed in house); electrical and tile work are being completed at the fire house; Kids Fisheree went well.

Fire Inspections – proposal received from Fire Inspection Service with cost of \$43 for properties that require twice
per year inspections and \$30 for properties that may need one inspection per year. Motion to accept bid for the fire
inspections for the Town of Mountain by O'Barski. Seconded by Carey-Mielke. Motion carried.

Animal Control Report – Ryan Giese stated there were a couple calls and collection of fees; working on Ordinance to present to the towns. No motions are entertained.

Cemetery Activity Update – Sexton Leah O'Barski stated there is a burial scheduled for this Saturday; no new calls for burials on books at this time; maintenance employee is back, and lawn mowers received maintenance. No motions are entertained.

Plan Commission Report - no meeting

7 Town Board/NOCCO Meetings Discussions – Sup. O'Barski recapped actions taken at Oconto County Board meeting regarding re-districting from NWTC to Nicolet College System; discussed Bike Trail System with preliminary maps created; presentation by OCEDC coordinator; Chair Maletzke stated that Mark from Bertram Wireless will be at next meeting to discuss new grants available for fiberoptics. No motions are entertained.

Communication File is reviewed, and list is signed.

Suring Public Library report —Jill Trochta, Library Director, gave report of services offered at the Suring Area Public Library; they are currently open to the public five (5) days per week; have free WiFi; five (5) public computers; summary of books available along with access to e-books to download; Friends of the Suring Public Library has Annual Rummage Sale, Book Sale, and Ice Cream Social; talked about summer library program for kids and adults; hoping to get other former programs back by this fall. No motions entertained.

Community Center exterior renovation bids – Sup. Carey-Mielke contacted Commonwealth Construction for breakdown of items from their proposal; recommendation to not accept bid; working on resubmitting proposal for exterior work to present at our next meeting. Tabled at this time.

O'Barski, Clerk Kauzlaric and Assessor Zillmer; along with citizen members Ann Maletzke and Leah O'Barski present and 0 in attendance; Sup. Carey-Mielke was absent; Assessor Zillmer has signed the affidavit in the assessment roll. Verification is given of notice posting on May 12, 2021 with publication as required.

The Board of Review Member Training Affidavit is for Chairman Maletzke, Sup. Carey-Mielke, Sup. O'Barski and Clerk Kauzlaric on March 7, 2020.

Open Book was held on May 26, 2021 from 2:00 – 4:00 p.m. by telephone with Assessor Zillmer; there are four (4) assessment changes, and the assessment roll was officially received. No objection forms have been filed with the Clerk.

Assessor Zillmer presents report of values; changes in net new construction higher than normal due to storm damage from 2019 work completed in 2020; value of property removed is also increased over previous year due to 2019 storm; discussed market adjustment to market classes-5,5m,6 and 7 may be needed; discussed budgeting for possible onsite (outside walk around) inspections of parcels by 2026.
