## TOWN OF MOUNTAIN SPECIAL TOWN ELECTOR MEETING - JUNE 8, 2021 MINUTES

The Special Town Elector Meeting was called to order by Chairman Maletzke at 6:30 p.m. pursuant to WI SS 60.12(1)(c) to vote on building expansions/renovations; with 30 voting electors, 4 town board members, 2 property owners and 2 guest attendees. Registration is by poll list verification pursuant to WI SS 60.11(7).

Town Office/Shop expansion project – Chair Maletzke presented preliminary drawings for Town Office/Shop additions; citizen concerns/questions;

- Any grant funding available
- Use of federal funding that is being released to municipalities.
- Question of property tax impact.
- Comment that addition of building will not assist with road access from trees down; road repairs; snow plowing completed.
- Inquiry of equipment inventory; value and mileage/hours on equipment
- Question of any new equipment to be purchased.

The meeting was called to order by Chair Maletzke at 7:52 p.m. at the Bill Lazansky Community Center following the Special Town elector meeting. Roll call was taken with Sup.O'Barski, Sup. Carey-Mielke, Chair Maletzke and Clerk/Treasurer Kauzlaric present, as well as 8 in attendance. The agenda was posted on June 5, 2021. Motion to approve the agenda posted on June 5, 2021, by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

**Treasurer's Report** was given by Clerk Kauzlaric with bank statements available for review. Motion to accept Treasurer's report by Carey-Mielke. Seconded by O'Barski. Motion carried.

Ambulance Report – Sup. Carey-Mielke presented overview of monthly calls, which are still above average; noted that Sunday, 5/23 accident at intersection of Section 4 Lane & State Highway 32/64 that resulted in death of individual.

- Intergovernmental Agreement review Sup. Carey-Mielke discussed Special meeting of the 3 Towns is tentatively scheduled June 24<sup>th</sup> to discuss amendment of the Intergovernmental Agreement in regards to professional audit due to cost estimate of \$5,000-\$7,000. Motion to approve removal of required audit by Maletzke. Seconded by Carey-Mielke. Motion carried.
- Purchase of Hydraulic Cots for Ambulances Sup. Carey-Mielke discussed purchase of two (2) refurbished hydraulic cots, FOMAS would purchase one (1) cot at cost estimate of \$10,000; which would leave an estimated cost of \$3,300 by each of the 3 Towns for the second cot. Motion to approve purchase by Carey-Mielke. Seconded by O'Barski. Motion carried.

Fire Department Report —Sup. O'Barski reviewed monthly calls from Chief Harkema's written report. No motions are entertained.

**Animal Control Report** – Sup. Carey-Mielke stated that Ryan Giese has issue with Pit Bulls in Town of Townsend; continues to work on Ordinance to present to the towns. No motions are entertained.
