12249 Sunset Ln Building Project – email received from prospective buyer inquiring about setback requirements approved by Oconto County in 2015; inquired on possibility of building 2 story home on lot. Motion to allow them to proceed with building project on 12249 Sunset Ln with Town of Mountain having no height restriction at this time and setbacks from 2015 are still allowed by Oconto County by Hermann. Seconded by Schink. Motion carried. **Recommendation to Town Board.**
