 Intergovernmental Agreement review – 3 Towns meeting to be held Thursday, August 19th immediately following the 6:30 p.m. Commissioner's meeting at the Ambulance Garage. No motions are entertained.

Fire Department Report – Chief Harkema unable to attend meeting; contact made to Clerk Kauzlaric and stated that Lappen Security is to be at the Fire Station to complete the work required; Captain Giese stated there were a couple calls. No motions are entertained.

- Hillside Drive turn around dedication Chair Maletzke reviewed discussion at Plan Commission meeting owners of property at 13522 Hillside Drive requesting variance from Town to build closer to road right-of-way for new construction; Plan Commission recommendation to allow property owners to move ahead with project plans and continue to work on the dedication of the easement of the land once actual placement of building/mound system would be; property owners at end of Hillside voiced concerns of run off from a mound system installation in rocky area; also discussed need for turn around appropriate to snow removal. Motion to approve by O'Barski. Seconded by Maletzke. Motion carried.
- 12249 Sunset Ln Building Project Chair Maletzke reviewed inquiry from individual of Oconto County variance on property and Town restrictions on building height limits; recommendation to notify individual that current set back variance and building height restrictions would be Oconto County issues to approve. Motion to respond with that answer and approve it by Maletzke. Seconded by O'Barski. Motion carried.
- Past Determination Schink's Marine & Motorsport (storage of repair work & sale of various items) Chair Maletzke reviewed discussion regarding compliance with original approval of Plan Commission on business plan and
