Rezone Application (Lloyd Schaut, 13080 State Highway 32/64) – Application available for review, along with maps indicating area to change from Industrial to General Commercial; discussed differences from Industrial vs General Commercial and any other possible zoning issues. Motion to approve rezone application by Herman. Seconded by Schink. Motion carried. Recommendation to Town Board.

Conditional Use Permit Application (Lloyd Schaut, 13080 State Highway 32/64) – application available for review, along with maps with plans for mini-storage unit plans drawn; members questioned size & height of units, proposed lighting to be used, questioned if fence will be installed between storage units and mill. Motion to accept the Conditional Use Permit Application by Schink. Seconded by Hertzberg. Motion carried. Recommendation to Town Board.

Speed Study discussion (State Highway 64 East) – Plan Commission Chair brought subject to meeting held March 29th; continued discussion of high traffic and speed of vehicles approaching the intersection of State Highway 64 East and State Highway 32; comments on increase in engine brake use by trucks in this area since new signage installed. Discussed Town Board to send letter to WI Dept. of Transportation for speed study from last residential parcel east of State Highway 32.

Past Determinations / Public Comments – question from Plan Commission members regarding Certified Survey map for Doze Inn property on Joppa Ln and property on Pavlat Lane (certified letters sent and returned for non-delivery); Public comment on concerns with rental properties (Air BNB's) in town and regulations for disturbances.
