SPECIAL TOWN ELECTOR MEETING – MAY 9, 2023

MINUTES

The Special Town Elector Meeting was called to order by Chairman Maletzke at 7:00 p.m. pursuant to WI SS 60.12(1)(c) to vote on sealed bids received for the Town Office/Road Shop project; with 25 voting electors, 4 town board members, and 4 non-voting/guest attendees. Registration is by poll list verification pursuant to WI SS 60.11(7). Motion to approve agenda by Ashley Rummel. Seconded by Johanna Ermis. Motion carried.

Sealed Bids for Town Office/Road Shop Expansion project – Two (2) bids were received; opened and total bid amount read by Clerk Kauzlaric; bids received:

- \$1,027,839 - Milbach Construction Services, Company
- \$952,667 – Bayland Buildings, Inc.

Public comments included – length of loan; interest rate and amount of interest to be paid; if we borrowed this amount, how hard would it be to borrow for other needs; suggestion of meeting for property owners to be able to attend and state their opinion.

Motion to move forward with project by Ann Maletzke. Seconded by Rod Christensen.
Discussion to move forward with bid review and investigation on available financing and possible grant options.


