## SPECIAL TOWN ELECTOR MEETING – JUNE 10, 2023

### MINUTES

The Special Town Elector Meeting was called to order by Chairman Maletzke at 9:00 am. pursuant to WI SS 60.12(1)(c) to vote on items listed on the agenda; with 66 voting electors (including 4 town board members), and 11 non-voting/guest attendees. Registration is by poll list verification pursuant to WI SS 60.11(7). Motion to approve agenda by Jody Wydeven. Seconded by Martin Lambrecht. Motion carried.

Chair Maletzke stated that public comments would be limited to 3 minutes.

The meeting started with Chair Maletzke providing a tour of grounds to show potential building site, cold storage building and kennel area.

**Bids for Town Office/Road Shop Expansion project** – Chair Maletzke reviewed the two (2) bids received:

- \$952,667 – Bayland Buildings, Inc.
- \$1,027,839 - Milbach Construction Services, Company

Information on lending interest rate and projected tax increase per \$100,000 value reviewed. Followed by public comments and questions.

Motion to approve Bayland Buildings bid by Georgene Schultz. Seconded by Nancy Lambrecht.


Chair Maletzke requested electors' suggestion on term of loan if vote to building would pass; majority hand vote was 15 year term.

Votes taken by paper ballot. Ballots read by Chair Maletzke with Michael Kresse; votes tallied by Clerk Kauzlaric and Virginia Lamal. 65 votes cast - Total vote count – Yes – 37; No - 28. Motion carried.

Motion to adjourn by Virginia Lamal. Seconded by Rodney Christensen. Motion carried.


