Carey-Mielke and Clerk/Treasurer Kauzlaric were present, as well as 10 in attendance; Chair Maletzke absent. The agenda was posted on July 8, 2023. Motion to approve the agenda by Carey-Mielke. Seconded by O'Barski. Motion carried. The Pledge of Allegiance is said.

Budget Amendments - none at this time

Disbursements were available for all to review; checks #17990 to and including #18054 in the amount of \$176,563.45, which includes auto withdrawal of Aflac, CenturyLink, WPS, Shell Fleet Card, and payroll taxes; plus late checks #18055 to and including 18057 in the amount of \$4,085.93, for a total disbursement of \$180,649.38. Motion to approve disbursements as presented by Carey-Mielke. Seconded by O'Barski. Motion carried.

Ambulance Report – Sup. Carey-Mielke reported June had 26 services calls with 19 transports (152 calls for 2023); 2004 Ambulance is for sale. No motions are entertained.

Fire Department Report – Chief Harkema reported training of live burn in Riverview next to Nicolet Plastics; brush fire on 7/10 (several in the area); discussed large fire ball at end of July Fireworks Celebration was part of show. Sup. O'Barski commented on event attendance, he also contacted Shawano softball league to inquire about getting teams for 2024 celebration event; Sup. O'Barski discussed fire inspection violation follow-ups.

Donation (Chief Steve Harkema) – donation of thermal imaging camera and two (2) retractable hose reels. Motion of
acceptance of the fire chief's donation of thermal imaging camera and retractable hose reels to the fire department by
Carey-Mielke. Seconded by O'Barski. Motion carried.

Animal Control Report – Nick M reported in June they had a Public Service Announcement on Facebook regarding dogs running at large and suggestions to watch appropriate chain size and rusty chains; Sup. Carey-Mielke mentioned dog being held and looking for possible foster/adoption. No motions are entertained.

Cemetery Activity Update – Sup. O'Barski stated two (2) burials scheduled for July with some pending; road to be repaved this year; shelter was completed by Suring High School's Construction Class; new lawn mower/tractor picked up. No motions are entertained.

Community Center / Parks reports – Sup. Carey-Mielke reported repairs completed from vandalism Memorial Day weekend; extra lights and possible security cameras to be added; the Oconto County Nutritional Site manager reported missing food/supplies from their inventory; Anderson Inland Lake District has been established and meetings continue.
